2. **Approval of January Meeting Minutes**

- It was motioned by Dan Pereira and seconded by Bob Joyce to approve the minutes of the Jan 11 meeting. The motion passed unanimously.

- Scotty reported that it was brought up at the AGM that expenses should be reported within one month of being spent.

- Dave reported that there will be no problem with audit in moving funds from DII to the San Jose Soccer Complex Foundation. A procedure needs to be in place for this to happen every 6 months or year. Dave will meet with Glen Cole, CYSA CFO to discuss the details.

- Melinda reported that on-line registration is moving forward. After board approval, contracts will then be signed with the vendors.

#### **5. Coordinator and Committee Reports**

##### **5.1. Referees**

- Dave reported that referees have been busy with State Cup, with good participation from younger referees. 20 younger referees are participating at Morgan Hill, and 10 have been selected for the round of 16 games.
- There will be a meeting tomorrow night for Referee Coordinators that Dave strongly recommends attendance. 14 Coordinators and 15 mentors will be attending. League Presidents are also welcome to attend.

- There will be no more use of the Morgan Hill Soccer Complex from the end of October. Efforts are being made to extend the date for District Cup. A decision by the City of Morgan Hill will be made within the next 60 days.
- Dave Mann reported that news of plans for the new Soccer Complex will start to get media attention. Dave Morton is the spokesperson and all inquiries by the media need to go through him.

- Paul advised Presidents to go to their coaches and remind them that all team officials on the bench area need to have the proper credentials (passes/paperwork).

- Dave Mann reported for Barry, who is out on travel, that he is requesting March 12/13 (semifinals) and March 19/20 (finals).

##### **5.11. District Cup**

- Jasbinder will be coordinating District Cup this year with help from Paul Vargas and Bob Joyce. Deadlines will be established early for proper planning. The assumption is that the Morgan Hill soccer Complex will not be available starting November. There are field scheduling conflicts that need to be resolved with ODP games. Expect that there will be a need for leagues to host Abonzino games at their home fields.

- Francis requested that if you are a new President or a new board member, you need to tell him how you want your information to be listed (home/work email, phone numbers etc).
- Hilario had a concern about there being conflicts at getting fields when there are limited fields that are being shared with baseball. Coaches need to ensure that they have enough players and do not cancel games. Mike Love also expressed concern that players must have a players pass. There are some players that play on multiple teams.
- There is a U10 girls team that wants to play up to U11. CYSA does not want to work against their intention, but the rule is that U10 teams cannot play U11. Dave Mann will talk to Pedro and will take a look at the specific situation.

**5.17. Tournaments**

- Issues regarding tournaments need to be raised first to Merijane to be addressed through the committee, then to Dave for the CYSA Board of Directors.
- Mike Love commented on a Juventus club on probation that violated CYSA paperwork rules. The league sanctioned by reducing 48 teams (previously reduced from 64) to 24 teams. An appeal has been made to CYSA, and Mike's concerns are that some of the factual allegations are incorrect, the sanctions are having a negative impact on the club and the penalties may not be appropriate to the rules violations. CYSA's focus is that that the rules are followed and clubs need to make that their priority.

**6. Commissioner's Report**

- Dave thanked all that went to Fresno for the AGM.
- Merijane is having some issues with U9 jamborees. Up to 3 are allowed outside of the district. Jamborees are not tournaments, and \$250 fees are not acceptable. All must keep to the approved format of \$50. Fees up to \$75 maybe acceptable to cover costs, but must be justified.
- Dave requested that Jack Salvemini bring a presentation to the board for the next meeting on Tops Soccer for disadvantaged/disabled youth.
- Dave requested that leagues with new registrars inform Melinda of changes and contact info.
