3. **Approval of November Meeting Minutes**

- Meeting minutes of the November District II Board of Directors meeting were approved as written.

4. **Treasurer's Report**

- District II financials for the period September through December 2005 (P&L) and for the period ending 12/31/05 (ending balance) were summarized as follows:

- The loss for the period was due to the \$200K donation to the soccer complex foundation.
- Reimbursement for District II Cup expenses requires approval by Jasbinder.
- Reimbursement for coaching class fees requires approval by Tim.

6. **Coordinator and Committee Reports**

6.1. **Referees**

- James Mayes reminded the board to submit nominations for male and female youth referee of the year.

- Dave announced that the San Jose Soccer Complex Foundation will be organized under the CYSA-N board, terms to be discussed. No monies will be transferred from the district to the foundation until the relationship between the foundation and the CYSA-N board is established.
- Dave reminded the board to submit applications for field reservations at the Morgan Hill Soccer Complex. The complex will be available for use until the end of 2006.

- Dave thanked Vic for filling in the vacated Abronzino president position for the 2005 season and informed the board that Pedro will be running for Abronzino president.

**6.7. Coaching**

- Tim announced that national D courses are posted at District II and CYSA-N websites. Dates are June 2, 3, 4 and June 9, 10, 11. A course at Morgan Hill is scheduled for July 12 – 16. The District will reimburse the \$400 fee for the class, paid to leagues after approval by Tim.
- Dave reminded the board that all U16 or older C1 coaches require at minimum a state D license. Dave will get clarification from Marco regarding licensing requirements for C3 coaches.

- Paul reported that state cup games start next week for younger age groups.
- Lining of fields – excessive rain has made lines difficult to see at Morgan Hill in the past. Dave Brown arranges for the fields to be lined. Dave Mann explained that the CYSA office should be notified if the lines are not done.

- Dave announced that Jasbinder is the new District II Assistant Commissioner, assuming responsibilities previously handled by Dan. Jasbinder is looking for his replacement for District Cup.
- Jasbinder thanked all leagues for volunteering to make District II cup a success.
- All expenses requiring reimbursement need to be sent to Jasbinder by the end of the month for his approval.
